## REQUIREMENTS FOR THESIS PREPARATION

1. Scientific papers that have not been published before are accepted for publication.

2. Materials should be submitted in Ukrainian (for Ukrainian citizens) or English for foreign participants.

3. The text of the abstract: MS Word, A4 sheet, 2 cm margins on all sides, Times New Roman font, size 14, spacing 1.5, paragraphs 1 cm.

4. The volume of abstracts is 2-4 pages. Number of authors - no more than two.

5. General scheme of thesis construction:

- information about the author is placed on the right: **bold, italics:** surname, initials; *italics:* name of the HEI - for each author; group - for higher education students; academic degree, academic title - for research and teaching staff;

- information about the supervisor (for higher education applicants): **bold, italics:** surname, initials; *italics:* name of the HEI, academic degree, academic title;

- the title of the abstract is in capital letters, in the centre (**bold**);

- the main text of the abstract.

6. The use of figures and tables in the abstract should be minimal. All figures should be grouped as a single object.

7. The sources used should be numbered according to the order of their mention in the text, or alphabetically. References to the source and pages in it are given in square brackets. The list of references is given at the end of the thesis in accordance with DSTU GOST

7.1 :2006 System of standards for information, library and publishing. Bibliographic record. Bibliographic description. General requirements and rules.

8. Entries that do not meet the requirements and are not submitted by the deadline will not be considered.
