Requirements for Abstracts Submission

It is expected that abstracts to be written on a relevant topic, contain in-depth scientific research, be carefully proofread, and be free of plagiarism.

The file title should correspond to the participant's last name, for example: Shevchenko-Abstract.

The text should be compiled in Microsoft Word and saved in *.doc or *.rtf format.

The title of the abstract should be centered (Times New Roman font #14, bold).

Below, single-spaced, centered – the author's first name, last name, academic degree, academic rank (if any), position, department, full name of the institution where the author studies or works, city, country; Times New Roman font #14.

The text of the abstract should be single-spaced and meet the following requirements: file format – A-4, margins: top, bottom, left, right – 2 cm, orientation – portrait, font – Times New Roman #14, line spacing – 1.5, style – Normal, paragraph indent – 1.25 cm.

The text volume is up to 3 pages.

Official languages of the Conference: Ukrainian, English.

After the Conference, the conference proceedings will be published on the website of State Tax University and the electronic copy will be sent to the authors.

It is forbidden to cite in the text and include in the references the sources published in Russian in any country, as well as sources in other languages if they are published in a state recognized by the Verkhovna Rada of Ukraine as an aggressor state.
