1. Scientific works that have not been published before are accepted for publication.

2. To participate, it is necessary to complete an application and send materials to the address: konf fin 2017@ukr.net

3. According to the results of the work of the round table, the following is expected:

- placement of participants' materials in a collective monograph, which will have an ISBN of the EU (Verlag. SWG imex GmbH, Nuremberg. Germany);

- preparation of recommendations for state structures, enterprises, public non-governmental organizations and all interested persons.

# REQUIREMENTS FOR FORMATION OF MATERIALS PROCEDURE OF THE APPLICATION:

1. Surname and first name of the participant

2. Position, place of work (study), academic degree, academic title.

3. Email

4. Contact phone number

The volume of materials is 12 pages. The language of the monograph is English.

The work is performed in the MS Word-6.0 editor (a version not older than Word-2003). The text should be saved with \*.doc extension, Times New Roman font, size 12, line spacing -1, paragraph indent -1 cm. Page format - A5, margins: top, bottom, left, right -2.0 cm.

The text must be executed in compliance with the requirements and appropriate stylistic editing.

Formulas, tables (Times New Roman code, size 10, line spacing - 1), drawings are made using special MS Office editors, must be signed and numbered consecutively with Arabic numerals and made in black and white (color drawings, graphs are not allowed). References to literary sources are made in the form of footnotes at the end of the page (Times New Roman font, size 8, line spacing - 1).

Maximum number of authors - three. Information on horizontal sheets is not allowed. Structure of the article: Introduction, Materials and Methods, Results and Discussion, Conclusions, Acknowledgements (if needed), References

The file name is the first author's last name. (example: ivanenko\_monog.doc).
