Text Fields - top - 30 mm, bottom - 25 mm, left - 30 mm, right - 20 mm;

Formulas and notation - typed in formulas editor MathType 6.0 or Microsoft Equation3.0 as separate object.

The volume of materials is from 12 pages. ***The language of the monograph is English.***

The work is performed in the editor MS Word (version not older than Word-2003). Text should be saved with the extension \*.doc, code Times New Roman, size 12, line spacing - 1, paragraph indent -1 cm. Page format - A5, edges: top, bottom, left, right - 2.0 cm.

The text must be executed in compliance with the requirements and appropriate stylistic editing.

Formulas, tables (code Times New Roman, size 10, line spacing - 1), figures are made using special editors MS Office, must be signed and sequentially numbered in Arabic numerals and made in black and white (color figures, graphics are not allowed). References are made in the form of footnotes at the end of the page (code Times New Roman, size 8, line spacing - 1).

The received materials pass obligatory reviewing. In the case of a positive review, the author is sent an invoice for payment for the publication of materials.

**The cost of the publication is 35 euros for 12 pages of text (complete or incomplete). The invoice will be sent by the author after acceptance of the materials for printing.**

The cost of publication includes: reviewing, layout, printing a monograph in a European publishing house and sending author's copies (until September 30, 2025).
