#### CONDITIONS OF PARTICIPATION

- **4.** Upon receipt of the materials, the Organizing Committee sends a confirmation letter to the participant's address within two days.
- **5.** The participant has the right to send only one report that has not been published before (including co-authorship).
  - **6.** The maximum number of authors is three (including the supervisor).
- **7.** Based on the results of the conference, participants will receive a certificate and a collection of conference materials in electronic form.

### Participation in the conference is free.

#### REQUIREMENTS FOR ABSTRACT PREPARATION

- 1. The volume of abstracts is up to 3 pages, which are not numbered.
- **2.** The font is Times New Roman, the size is 14, the line spacing is 1.5, the paragraph is 1 cm, the size of all margins is 20 mm.
- **3.** The use of illustrative materials in abstracts should be minimal. The font size in the table is 12, the heading is 14.
  - **4.** The format of tables and figures should be only portrait.
- **5.** The author and the supervisor are responsible for the content and design. The sequence of placement of materials in the abstracts of the report:
  - UDC (in the upper left corner) 12 font;
  - title of the abstract of the report (capital letters, font bold);
  - surname and initials of the author (no more than two);
  - name of the higher education institution;

- text;
- The list of sources used should be drawn up in accordance with the requirements used for the design of scientific papers. References to sources should be indicated in the text in square brackets by the serial number of this work according to the list of sources used.
