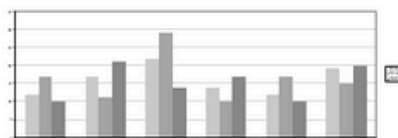


Fig 1 - Figure description (TNR 14pt., Center-aligned)
