### Submission Guidelines for Abstracts:

Abstracts must address current topics, demonstrate rigorous scholarly research, be thoroughly proofread, and be free of plagiarism.

The file name must correspond to the participant's surname, for example: Shevchenko\_Abstract.

The text must be prepared in Microsoft Word and saved in \*.doc or \*.rtf format.

The title of the paper must be centred on the line (Times New Roman, 14 pt, bold).

One line spacing below, centred — the author's first name and surname, academic degree, academic title (if applicable), position, department, full name of the institution where the author studies or works, city, country; Times New Roman, 14 pt.

One line spacing below — the body text of the abstract, which must comply with the following requirements: page format — A4; margins: top, bottom, left, right — 2 cm; orientation — portrait; font — Times New Roman, 14 pt; line spacing — 1.5; style — Normal; paragraph indent — 1.25 cm.

**Length of Text:** up to 4 pages.

**Working Languages of the Conference:** Ukrainian, English.

It is strictly prohibited to cite in the text or include in the list of references any sources published in the Russian language in any country, as well as sources in other languages if they were published in a state recognized by the Verkhovna Rada of Ukraine as an aggressor state.
