Decision has been incorporated into our [Exemption Calculator](#). Qualification may require reassessment against future updates to the CGMA syllabus if the program continues to be offered in later years.

Accredited bachelor's and master's programs have been added to our database, and STU graduates can now receive tuition exemptions from a certain level (see Appendix 1).

The proposed entry route does not require from students any form of submission to us, as exemptions are now awarded automatically after completing educational background upon registration.
