

The elective course for master's students has started.

On March 01, 2025, the State Tax University launched an optional course: “Taxation and the EU Common Tax Policy” within the framework of the Jean Monnet Module ‘Building a Sustainable Interest in EU Tax Culture through the Implementation of Educational, Scientific and Communication Outreach Activities Focused on Ukrainian Society’ (Grant Agreement No. 101125984 - TIEU).

Teachers of the Department of Tax Administration of the Faculty of Taxation, Accounting and Audit, Professor Volodymyr Andrushchenko and Associate Professor Tetiana Tuchak, conducted classes for applicants for higher education of the second (master's) level of full-time education in educational and professional programs: «Accounting and Taxation in Business Management», «State Audit; Forensic Economic Expertise in Financial Investigations», «Management Accounting and Business Analytics», «Tax Consulting», «International taxation», «Fiscal Administration», «City and Regional Economics», «Business Psychology», «Public Management of Financial Activities of the State and Local Governments», «Management of Economic and Legal Activities», «Legal Support of the State's Financial Security», «National Financial Security».

The grant project implementers described the purpose and objectives of the elective and outlined the educational goals of the project. The course started with topic 1: The EU as a fiscal and solidarity union of states. The elective promotes the dissemination and implementation of best taxation practices and traditions of the EU tax culture in Ukraine. The course is designed to develop new competencies and generate new knowledge among students who will become agents of change in the field of taxation, to promote the harmonization of national tax legislation with European standards in the context of Ukraine's acquisition of the EU candidate status and implementation of European integration steps.
