



Partnership Agreement

The IDEA Academy, represented by the Principal, Vincent Maione, and The State Tax University represented by the Acting Rector Dmytro Serebrianskyi, hereinafter referred to as the "Parties", guided by international and national regulatory legal acts governing science and education relations, have entered into this Agreement about follows:

1. Subject of the Agreement

The subject of the Agreement is international cooperation in the field of science and education, the advancement of higher education systems, the training of highly qualified professionals with higher education and scientific personnel, the continuous employee's professional development, the integration of education and science, as well as the promotion of cultural and social interactions.

2. Forms of Interaction

In the process of implementing cooperation within the framework of this Agreement, the Parties may organize the following forms of interaction:

- 2.1. Joint meetings and discussions about the Agreement.
- 2.2. Planning of joint activities (development of programs) aimed at achieving the goals of this Agreement.
- 2.3. Preparation and implementation of joint research programs, research works in certain scientific areas.
- 2.4. Mutual preparation of joint scientific and methodological publications, monographs, popular science publications, articles, teaching aids, etc.
 - 2.5. Peer review of scientific papers and methodological materials.
- 2.6. Consultations on issues related to the activities of the Parties and of mutual interest.
- 2.7. Assistance in disseminating information on methodological developments, training programs, publications of the Parties.
- 2.8. Organization of scientific and technical expertise of projects and programs and other types of expertise with the participation of employees of the Parties.
- 2.9. Academic exchange of specialists within the framework of educational and scientific programs for teaching and lecturing (guest lecturing).
- 2.10. Involvement of students, undergraduates, and postgraduates in research work in priority areas of fundamental and applied scientific research.

2.11. Development and implementation of professional development programs for teachers and staff.

2.12. Implementation of joint projects, courses, seminars on training,

retraining and advanced training of specialists.

2.13. Organization of joint conferences, seminars, symposia, exhibitions, and other forms of presentation of the results of research work.

2.14. Participation of students, postgraduates, doctoral students, and staff in joint scientific, technical, and innovative events organized by the Parties. In cases of relations where one or the other Party entrusts the other Party with the performance of specific work stipulated by this Agreement, involving remuneration for the performance of work, such relations shall be formalized by separate contracts (agreements) for the providing of work and services, with reference to this Agreement.

3. Rights and Obligations of the Parties

- 3.1. The Parties, based on their professional competence, skills, availability of material and financial resources, have the right to:
- 3.1.1. To exchange information on promising scientific and innovative projects and educational programs within the framework of the current legislation, to request the necessary information on issues that are the subject of cooperation within the framework of this Agreement.
- 3.1.2. To exchange experiences on issues that are the subject of cooperation within the framework of this Agreement.
- 3.1.3. To organize consultations, lectures, retraining courses, and other forms of advanced training for the Parties, invite them to joint meetings, seminars, webinars.
- 3.1.4. To initiate the involvement of the other Party in the organization and holding of joint events, conferences, meetings, symposia, exhibitions, fairs, and other events related to issues of cooperation within the framework of this Agreement.
- 3.1.5. To invite the other Party in the organization and conduct of joint scientific research, the expert assessment of and technical developments.
- 3.1.6. To draw up and conclude contracts and agreements for the performance of research and applied work.
- 3.1.7. To perform other work and interaction within the scope of the subject of the Agreement.
- 3.2. The Parties, based on their professional and production competence, skills, availability of resources, undertake:
- 3.2.1. To discuss issues related to the implementation of areas of cooperation.
- 3.2.2. To consider problems arising in the process of implementation of this Agreement, make coordinated decisions on them.
- 3.2.3. To comply with the ethical standards, rules of conduct and safety of the Parties.
 - 3.2.4. To keep official, commercial, and other secrets protected by the

legislation.

- 3.2.5. To ensure protection and control of access to information and documentation received from the other Party.
- 3.2.6. Not to use intellectual property, patents, know-how for commercial purposes without the consent of the other Party.
- 3.2.7. Not to publish the results of joint activities without the consent of both Parties.

4. Final Provisions

- 4.1. Specific forms of cooperation between the Parties are stipulated by separate contracts or agreements that consider the wishes of the Parties in all aspects of activity.
- 4.2. This Agreement is concluded without mutual financial conditions of the Parties. Financial terms and conditions are stipulated in contracts that are additionally concluded between the Parties.
- 4.3. As part of the implementation of this Agreement, the Parties shall ensure the protection of rights to the results of intellectual activity.
- 4.4. Any changes and additions to the terms and conditions of this Agreement shall be formalized by additional agreements and shall come into force from the moment of their signing by both Parties.
- 4.5. This Agreement shall enter into force from the date of its signing and shall be valid for five years. Either Party has the right to terminate the memorandum without liability by giving six months' notice in writing of such intent.
- 4.6. This Agreement is made in two copies of the same legal force and is kept by each of the Parties.
